

Fleetwood Community Pool Lifeguard Information

We are currently seeking to hire lifeguards to work at our facility for the 2018 summer season.

Important information to consider before completing the application process:

- All applicants must be at least 15 years of age by May 1.
- If you do not currently have your lifeguarding certification, you would need to participate in that training and pass the course in order to ensure your employment. If you are offered employment, the certification process will be discussed.
- The summer season begins on Memorial Day weekend (May 26, 2018) and ends on Labor Day (September 3, 2018). You will be scheduled to work shifts between the hours of 7:30am – 7:45pm daily and 7:30am – 10:15 pm on Thursdays. The normal operating hours of the pool are 12:00-7:30pm daily; however, the hours are 12:00-10:00pm on Thursdays. Swim team practice and YMCA groups are held in the morning hours. We also rent the pool for private parties, so you might be scheduled to work up to 10:15pm on days other than Thursdays.
- In addition to lifeguarding during the normal operating hours, lifeguards will be responsible to complete the following tasks: clean bathroom facilities; clean the pool and surrounding areas; work in the pool office; provide lifeguarding services for swim team, playground, and private parties; and provide swim instruction during swim lessons.
- Hourly pay rate will be discussed during the interview process. All pay rates are above minimum wage.
- Guards will be required to purchase a red “lifeguard” swim suit, which must be pre-approved by management.
- Employment is seasonal. If you are offered a position this summer, you are not guaranteed employment outside of the 2018 summer season.
- **Applications must be received by Friday, February 9, 2018 at the address below.**
